PLANNING -KAREN SULLIVAN OTSEGO NOW -JODY ZAKREVSKY

Karen Sullivan stated there were two responses to the I-88 Corridor Study RFP and gve an update on the program income funding. The committee discussed allocating some of the program income funding to hire an energy consultant and for a feasiblity study for the Richfield Springs Industrial Park. Karen Sullivan stated she will meet with the Treasurers office to get an updated certification as to the remaning funds.

Representative Marietta moved for approval to amend the program income resolution to eiliminate the Coditum project and include the energy consultant and Richfield Springs Industrial Park feasibilty study. Seconded, Oberacker. Total: 2,393; Ayes: 2,393. Motion carried.

Karen Sullivan stated she will arrange a conference call to include Jody Zakrevsky and Jason Purvis of the Office of Community Renewal to get clarification on the use of program income funds.

Leslie Orzetti asked Jody Zakrevesky about the decompressor station project.

Jody Zakrevsky distributed a copy of a draft contract between the County of Otsego and the County of Otsego IDA for the appropriated \$75,000. An electronic version had been distributed prior to the meeting. Representative Farwell moved to approve the contract as presented. Seconded, Oberacker. Total: 2,393; Ayes: 2,393. Motion carried.

Representative Oberacker moved for approval to enter into an executive session to include Karen Sullivan and Jody Zakrevsky to discuss contracts. Seconded, Farwell. Total: 2,393; Ayes: 2,393. Motion carried.

The committee reconvened.

Representative Oberacker moved for approval to accept the bid from McFarland and Johnson for the I-88 Corridor study based on their feasibilty matrix, qualifications of staff and consultants and scoring 25 points higher on an objective scoring rubric. Seconded, Marietta. Total: 2,393; Ayes: 2,393. Motion carried.

Karen Sullivan asked the committee to give attention to filling a vacancy on the Southern Tier 8 Board and that anyone interested should inform the Otsego County Board Chair.
