

**LOCAL LAW NO. 1 OF 1915
COUNTY OF OTSEGO, NEW YORK**

**AN ACT FIXING THE TAX TO BE IMPOSED ON DOGS IN THE SEVERAL
TOWNS OF THE COUNTY OF OTSEGO**

The Board of Supervisors of Otsego County, pursuant to Section 110 of Chapter 16 of the Laws of 1909, being Chapter 11 of the Consolidated Laws, and known as the County Law, do enact as follows:

There shall be annually levied and collected in the several Towns of the County of Otsego the following tax on dogs over four months old; upon every bitch owned or harbored by any one or more persons, or by any family, three dollars (\$3.00).

Upon every additional bitch owned or harbored by the same person or persons or family, Five Dollars (\$5.00).

Upon every dog other than a bitch owned or harbored by one or more persons or by any family, One Dollar (\$1.00), and upon every additional dog other than a bitch owned or harbored by the same person or persons or family, Two Dollars (\$2.00).
