

**LOCAL LAW NO. 1 OF 1957
COUNTY OF OTSEGO, NEW YORK**

**A LOCAL LAW OF THE COUNTY ESTABLISHING THE
POSITION OF COUNTY FORESTER**

Be it enacted by the Board of Supervisors of the County Otsego as follows:

Section 1. Pursuant to Section 400, paragraph 4, of the County Law there hereby is created and established for the County of Otsego the office of County Forester.

Section 2. The County Forester shall be appointed by resolution of the Board of Supervisors for the term of office for which the then members of such board were elected.

Section 3. It shall be the duty of the County Forester to administer the county program of reforestation as outlined by the Forestry Committee of the Board of Supervisors.

Section 4. The County Forester shall be a county officer in the Unclassified Service and the amount of his compensation shall be fixed by the Board of Supervisors.

Section 5. This law shall take effect on March 1, 1957.
