A LOCAL LAW TO PROVIDE FOR AN INCREASE IN THE
SALARY OF THE COUNTY COMMISSIONER OF SOCIAL
SERVICES OF THE COUNTY OF OTSEGO

BE IT ENACTED by the Board of Supervisors of the County of Otsego as follows:

Section 1. That the salary of the Otsego County Commissioner of Social Services shall be \$10,000.00 per year payable in equal monthly installments.

Section 2. This local law shall take effect February 17, 1968.
