INTRODUCTION NUMBER 1

A local law establishing the salaries for the Otsego County Surrogate.

BE IT ENACTED by the Board of Representatives of the County of Otsego as follows:

Section 1. That the salary for the Otsego County Surrogate be and it hereby is established at the sum of Twenty-Six Thousand Five Hundred Dollars (\$26,500.00) per year.

Section 2. This local law shall take effect March 1, 1972.
