

**LOCAL LAW NO. 1 OF 1998
COUNTY OF OTSEGO, NEW YORK**

**A LOCAL LAW RESCINDING LOCAL LAW NO. 1 OF 1997
ENTITLED THE SHELF MARKING AND SCANNER ACCURACY LAW**

BE IT ENACTED by the Otsego County Board of Representatives as follows:

Section 1. Narrative - Legislative Intent.

The County of Otsego enacted Local Law No. 1 of 1997, entitled the Otsego County Shelf Marking and Scanner Accuracy Law. It now appears that certain of the provisions thereof are inequitable to certain businesses within the County; that in contrast to matters of weight and measure for which inspections are required as no other independent verification is available to the general public relying on weights and measures, the customer presented with any scanner system is able to check the accuracy of the items presented against the sales tape of such sales without need of this law.

The County of Otsego therefore determines for the reasons set forth above that the aforescribed Shelf Marking and Scanner Accuracy Local Law is unnecessary at this time and should be rescinded.

Section 2. Rescinding of Local Law.

The Otsego County Board of Representatives does hereby rescind Local Law No. 1 of 1997 entitled the Otsego County Shelf Marking and Scanner Accuracy Law.

Section 3. Effective Date.

This local law shall become effective immediately upon filing with the Office of the Secretary of State.

This local law is offered by the Intergovernmental Affairs Committee.
