A LOCAL LAW ESTABLISHING THE SALARIES OF COUNTY CLERK, COUNTY TREASURER, COMMISSIONER OF SOCIAL SERVICES, SUPERINTENDENT OF HIGHWAYS, COMMISSIONER OF ELECTIONS (D), DIRECTOR OF REAL PROPERTY TAX SERVICES II, PERSONNEL OFFICER, AUDITOR AND CLERK OF THE BOARD, COUNTY ATTORNEY AND DIRECTOR OF INFORMATION TECHNOLOGIES FOR THE YEAR 2015

BE IT ENACTED, by the Board of Representatives of the County of Otsego as follows:

SECTION 1. The salary for County Clerk is established at an annual sum not to exceed Fifty-Four Thousand One Hundred Eighty-Five Dollars (\$54,185.00).

SECTION 2. The salary for County Treasurer is established at an annual sum not to exceed Sixty-Five Thousand Eight Hundred Seventy-Eight Dollars (\$65,878.00).

SECTION 3. The salary for Commissioner of Social Services is established at an annual sum not to exceed Sixty-Eight Thousand Five Hundred Fifty-Nine Dollars (\$68,559.00).

SECTION 4. The salary for Superintendent of Highways is established at an annual sum not to exceed Fifty-Seven Thousand Three Hundred Fifty-Two Dollars (\$57,352.00).

SECTION 5. The salary for Commissioner of Elections (D) is established at an annual sum not to exceed Seven Thousand Three Hundred Seventy-Two Dollars (\$7,372.00).

SECTION 6. The salary for Director of Real Property Tax Services II is established at an annual sum not to exceed Fifty-Two Thousand Five Hundred

Dollars (\$52,500.00).

SECTION 7. The salary for Personnel Director is established at an annual sum not to exceed Fifty-Four Thousand Three Hundred Ninety-Nine Dollars (\$54,399.00).

SECTION 8. The salary for Auditor and Clerk of the Board is established at an annual sum not to exceed Forty-Seven Thousand Nine Hundred Ninety Dollars (\$47,990.00).

SECTION 9. The salary for County Attorney is established at an annual sum not to exceed Sixty-Seven Thousand Nine Hundred Thirty-Seven Dollars (\$67,937.00).

SECTION 10. The salary for Director of Information Technologies is established at an annual sum not to exceed Sixty-Four Thousand Two Hundred Dollars (\$64,200.00).

SECTION 11. This Local Law shall take effect January 1, 2015.
