

LOCAL LAW NO. 2 OF 1962  
COUNTY OF OTSEGO, NEW YORK

A LOCAL LAW TO PROVIDE FOR AN INCREASE IN THE  
SALARY OF THE COUNTY SUPERINTENDENT OF  
HIGHWAYS OF THE COUNTY OF OTSEGO

BE IT ENACTED by the Board of Supervisors of the County of Otsego as follows:

**Section 1.** That the salary of the Otsego County Superintendent of Highways shall be \$7,500.00 per year payable in equal monthly installments.

**Section 2.** This local law shall take effect January 1, 1963.
