

LOCAL LAW NO. 2 OF 1977  
COUNTY OF OTSEGO, NEW YORK  
A LOCAL LAW TO BE KNOWN AS  
THE ENVIRONMENTAL QUALITY REVIEW ACT

BE IT ENACTED, by the Board of Representatives of the  
County of Otsego, as follows:

Section 1. Pursuant to Article 8 of the New York State Environmental Conservation Law, the County of Otsego must provide for environmental quality review of actions which may have a significant effect on the environment.

Section 2. The County of Otsego shall fully undertake and exercise its regulatory authority with regard to activities subject to environmental quality review of actions which may have a significant effect on the environment. Such regulatory authority shall be undertaken and exercised in accordance with all of the procedure concepts and definitions set forth in Article 8 of the New York State Environmental Conservation Law and pursuant to regulations promulgated by the New York State Department of Environmental Conservation, in accordance with Section 8-0113 of the Environmental Conservation Law, and as such law and regulations may from time to time be amended.

Section 3. The Otsego County Director of Planning is hereby designated as the officer of the County responsible for the application and enforcement of the within Local Law, subject to review by the Board of Representatives.

Section 4. The Otsego County Director of Planning is hereby directed and authorized to promulgate such rules, regulations and requirements as are necessary to comply with Article 8 of the New York State Environmental Conservation Law. Such rules, regulations and requirements shall be presented to and adopted by resolution of this Board of Representatives.

Section 5. This Local Law shall take effect immediately upon filing with the Secretary of State.

This Local Law is offered by the Environmental Affairs Committee.


