

LOCAL LAW NO. 2 OF 1982
COUNTY OF OTSEGO, NEW YORK

A LOCAL LAW ESTABLISHING THE SALARY
FOR HIGHWAY SUPERINTENDENT

BE IT ENACTED by the Board of Representatives of the
County of Otsego, as follows:

Section 1. The salary for the Superintendent of
Highways be and hereby is established at the sum of Twenty-four
Thousand Five Hundred Dollars (\$24,500.00) per annum, commencing
February 22, 1982;

Section 2. This Local Law shall take effect forty-five
(45) days after it shall have been adopted and certified
copies thereof have been filed as required by Section 27 of the
Municipal Home Rule Law.
