

LOCAL LAW NO. 2 OF 1995  
COUNTY OF OTSEGO, NEW YORK

A LOCAL LAW BANNING POSSESSION OF FIREARMS  
AND OTHER DANGEROUS WEAPONS IN  
OTSEGO COUNTY BUILDINGS

SECTION 1. LEGISLATIVE INTENT

The County of Otsego, through its Board of Representatives and in its proprietary capacity, declares that it is necessary, for the security, safety, protection and well-being of its employees, and its property and individuals present thereupon, to place restrictions on the bearing and possession of firearms and other dangerous weapons and instruments by individuals while entering into and being present in buildings owned, leased and operated by the County of Otsego.

SECTION 2.

This local law prohibits any individual from bearing or having in his/her possession, either openly or concealed, any firearm, gun, explosive device or substance, lethal or debilitating chemical or gas, or any dangerous or deadly weapon or instrument of any description, including but not limited to all firearms (i.e. handguns, pistols, target pistols, revolvers, rifles, shotguns, etc.), all illegal weapons (i.e. dangerous knife, dagger, dirk, razor, stiletto, etc.), any knife or any imitation pistol while entering into or while being present in any building owned, leased, or operated by the County of Otsego.

SECTION 3.

This local law shall not apply to law enforcement officials only.

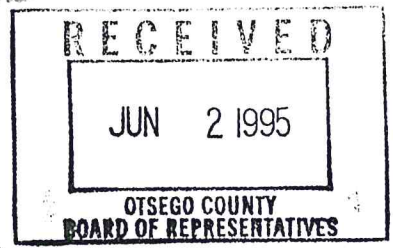
SECTION 4.

Failure to comply with this local law shall be punishable by confinement in the Otsego County Correctional Facility for a term not to exceed three (3) months and/or a fine not to exceed five hundred dollars (\$500.00)

SECTION 5. EFFECTIVE DATE

This local law shall become effective immediately upon adoption.
