

**LOCAL LAW NO. 2 OF 2011
COUNTY OF OTSEGO, NEW YORK**

**A LOCAL LAW ESTABLISHING THE COUNTY PLANNING DEPARTMENT AS THE SOLE
COUNTY PLANNING AGENCY FOR PURPOSES OF REFERRALS UNDER NEW YORK
STATE GENERAL MUNICIPAL LAW, ARTICLE 12-B, SECTIONS 239-l, m AND n**

BE IT ENACTED by the Board of Representatives of the County of Otsego as follows:

Section 1. Title

This local law shall be known as the Law Establishing the County Planning Department as the Sole County Planning Agency for Purposes of Referrals under New York State General Municipal Law, Article 12-B, Sections 239-l, m and n.

Section 2. Purpose:

The purpose of this local law is to designate and empower the Otsego County Planning Department as the sole county planning agency for the purposes of referrals under New York State General Municipal Law, Article 12-B, Sections 239-l, m and n.

Section 3. General Provisions:

(a) The Planning Department of Otsego County shall be, for the purposes of municipal referrals under New York State General Municipal Law, Article 12-B, Sections 239-l, m and n, the sole county planning agency.

(b) The Planning Department shall have and exercise, for the purpose of municipal referrals under New York State General Municipal Law, Article 12-B, Sections 239-l, m and n, all the powers and duties of a county planning agency under such sections.

Section 4. Separability:

If any provision of this local law, or the application thereof to any person or circumstances, is held invalid, the remainder of this local law, and the application of such provisions to other persons or circumstances, shall not be affected thereby.

Section 5. Effective Date:

This local law shall take effect immediately upon its adoption.
