

**LOCAL LAW NO. 3 OF 1968
COUNTY OF OTSEGO, NEW YORK**

**A LOCAL LAW PROVIDING FOR A SALARY SCHEDULE
FOR CERTAIN OFFICES IN THE COUNTY OF OTSEGO**

BE IT ENACTED by the Board of Supervisors of the County of Otsego as follows:

Section 1. That the following compensation schedule for the offices indicated be and the same is hereby established:

Otsego County Court Judge.....	\$26,000.00
Otsego County Surrogate.....	\$26,000.00
Commissioner of Social Services.....	\$10,500.00
Auditor and Clerk of the Board of Supervisors.....	\$10,500.00
Superintendent of Highways.....	\$11,000.00
County Attorney.....	\$10,500.00

Section 2. The local law shall take effect March 1, 1969.
