

LOCAL LAW NO. 3 OF 1983

A LOCAL LAW ESTABLISHING THE SALARY
FOR COUNTY AUDITOR AND CLERK OF THE
BOARD OF REPRESENTATIVES

BE IT ENACTED, by the Board of Representatives of the
County of Otsego as follows:

Section 1. The salary for the County Auditor and
Clerk of the Board of Representatives is established at the
sum of Twenty One Thousand Dollars (\$21,000.00) per annum,
commencing June 20, 1983;

Section 2. This Local Law shall take effect forty-five
(45) days after it shall have been adopted and certified copies
thereof have been filed as required by Section 27 of the Municipal
Home Rule Law.
