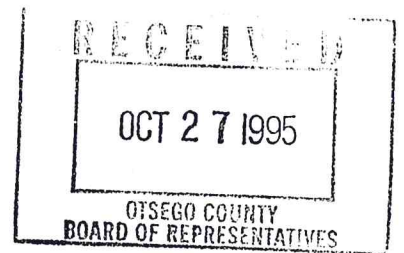


COUNTY OF OTSEGO, NEW YORK
LOCAL LAW NO. 5 OF 1995



A LOCAL LAW ESTABLISHING THE SALARIES OF COUNTY CLERK,
COUNTY TREASURER, SHERIFF, COMMISSIONER OF SOCIAL SERVICES
GROUP I, EMERGENCY SERVICES COORDINATOR, DIRECTOR OF
REAL PROPERTY TAX SERVICES II, PERSONNEL OFFICER, AND ELECTION
COMMISSIONER FOR THE YEAR 1996

BE IT ENACTED, by the Board of Representatives of the County of Otsego as follows:

SECTION I. The salary for County Clerk is established at a sum not to exceed Thirty-Seven Thousand One Hundred Thirty-Two Dollars (\$37,132.00).

SECTION II. The salary for County Treasurer is established at a sum not to exceed Forty-Two Thousand Four Hundred Thirty-Six Dollars (\$42,436.00).

SECTION III. The salary for Sheriff is established at a sum not to exceed Forty-One Thousand Nine Hundred Six Dollars (\$41,906.00).

SECTION IV. The salary for Commissioner of Social Services Group I is established at a sum not to exceed Forty-Five Thousand Six Hundred Nineteen Dollars (\$45,619.00).

SECTION V. The salary for Emergency Services Coordinator is established at a sum not to exceed Twenty-Eight Thousand Six Hundred Forty-Five Dollars (\$28,645.00).

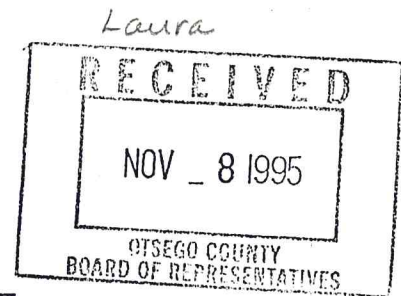
SECTION VI. The salary for Director of Real Property Tax Services II is established at a sum not to exceed Thirty-One Thousand Five Hundred Thirty-Six Dollars (\$31,536.00).

SECTION VII. The salary for Personnel Officer is established at a sum not to exceed Twenty-Nine Thousand Nine Hundred Ninety-Seven Dollars (\$29,997.00).

SECTION VIII. The salary for Election Commissioner is established at a sum not to exceed Three Thousand Seven Hundred Fourteen Dollars (\$3,714.00)

SECTION IX. This Local Law shall take effect January 1, 1996.

This Local Law is offered by the Budget Ways and Means Committee.
