COUNTY OF OTSEGO, NEW YORK

A LOCAL LAW ESTABLISHING THE SALARY FOR THE
DIRECTOR-REAL PROPERTY TAX SERVICE

Be it enacted by the Board of Representatives of the
County of Otsego as follows:

Section 1 - The salary for the Director - Real Property Tax Service be and it is hereby established at the sum of Ten Thousand Five Hundred Dollars (\$10,500.00) per year.

Section 2 - This Local Law shall take effect on the 20th day after it shall have been adopted, and certified copies thereof have been filed as required by Section 27 of the Municipal Home Rule Law.

Mr. Tisenchek reported the Committee had met with Mr. Morrison concerning the fire maintenance contract, the installation of Motorola equipment with the District Manager of Motorola. Mr. Tisenchek reported the Committee had met with Mr. Elliott concerning additional positions available under the PEP Program, the qualifications for County Planner, a back-up telephone operator for the County Office Building, the Otsego booklet, applications for Public Defender, Traffic Safety Board and requested recognition of the letter from the American Legion.

Mr. Higgins retired to his own chair and Mr. Bresee again resumed Chairmanship.

Mr. Higgins reported the Finance Committee had met and discussed Revenue Sharing with Mrs. Jones, had received figures from her as to surpluses in the Welfare Department and the amount received from Sales Tax. Mr. Higgins also reported the Committee had met with Mr. Bratton regarding the purchase of a printer, the transfer of the map file from the County Clerk to Mr. Bratton and had opened bids. Mr. Higgins reported about the discussion of the purchase of Xerox supplies and the applications for Director of the Data Processing Department.

Mr. Winsor reported the Sanitary Land Fill Committee had held their final meeting and now all municipalities had been informed of the guide lines to be followed in the junk car removal. Mr. Winsor also reported a letter had been received from the State Department of Audit and Control ruling there was not a conflict of interest in Dr. Cannon being Medical Director.

Mr. Higgins moved Local Law No. 1 of 1973 be taken from the table and acted upon at this time.

Messrs. Brenner and Tisenchek seconded the motion of Mr. Higgins. Motion carried.

The roll was called on the adoption of Local Law No. 1 of 1973 and resulted as follows:
